12 approval of the Board of Estimate and Apportionment, to expend any funds received by said
13 grants to fulfill the obligations of the grants, and containing an emergency clause.

17 **SECTION ONE:** The Mayor, on the behalf of the City of St. Louis, is hereby authorized and
18 directed to submit all necessary applications and to enter into any agreements with the State of
19 Missouri, Department of Health and Senior Services (Grant# 3M0300006-11) for the “Child &
20 Adult Care Food-I Am Moving, I am Learning” Program and authorizing the Mayor, upon
21 approval of the Board of Estimate and Apportionment, to expend any funds received by said
22 grant to fulfill the obligations of the grant.

24 **SECTION TWO:** Emergency Clause. This being an ordinance for the preservation of public
