1 An Ordinance recommended by the Planning Commission repealing §18 of Ordinance
2 59979, and also repealing Ordinances 60949, 63686, 63858, 64459, 65790, which amended
3 Ordinance 59979 which ordinances are codified as Section 26.68 of the Revised Code of the City
4 of St. Louis; repealing Ordinance 60704 and 62701, which amended Ordinance 60704, and is
5 codified as Section 24.44 of the Revised Code of the City of St. Louis; and enacting a new
6 Ordinance which will amend Section 26.68 of the Revised Code of the City of St. Louis by
7 adding definitions, new regulations and prohibiting digital outdoor general advertising devices
8 and digital signs in certain districts; containing a substitution clause, penalty clause, savings
9 clause, severability clause, and emergency clause.

10 **WHEREAS**, Ordinance 68606, approved on March 16, 2010, established a 12-month
11 moratorium on the erection, construction or installation of any digital signs or digital outdoor
12 general advertising devices and on the replacement of existing non-digital static display signs
13 and outdoor general advertising devices with digital signs and digital outdoor general advertising
14 devices;

15 **WHEREAS**, Ordinance 68606 required that the Zoning Section of the Department of
16 Public Safety and the Planning and Urban Design Agency submit to the Board of Aldermen
17 proposed regulations for digital signs and digital outdoor general advertising devices;

5 26.68.010 **Scope of chapter.**

6 These regulations shall govern and control the erection, remodeling, enlarging, moving,
7 operation and maintenance of all signs by conforming uses within all zoning districts. Nothing
8 herein contained shall be deemed a waiver of the provisions of any other ordinance or regulation
9 applicable to signs. Signs located in areas governed by several ordinances and/or applicable
10 regulations shall comply with all such ordinances and regulations.

11 **26.68.020 Definitions.**

12 For the purpose of this chapter the following terms, phrasing, words and their deviations shall
13 have the meaning given herein:

14 1. **Animation or Animated Sign.** "Animation or Animated sign" means any sign or part
15 of a sign which changes physical position by any movement or rotation, including electronic and
16 video display changed by remote or automatic means.

17 2. **Area of Sign.** The area of a sign shall be measured in conformance with the
18 regulations as herein set forth provided that the structure or bracing of a sign shall be omitted
19 from measurement unless such structure or bracing is made part of the message or face of the
20 sign. Where a sign has two faces at a right angle to the building or street, the area of one face

1 shall determine the area of the sign. Where a sign has two faces not at a right angle to the
2 building or street or has three or more faces, the area of all faces shall determine the area of the
3 sign.

4 a. **Sign With Backing.** The area of all signs with backing or a background,
5 material or otherwise, that is part of the overall sign display shall be measured by
6 determining the sum of the areas of each square, rectangle, triangle, portion of a circle or
7 any combination thereof which creates the smallest single continuous perimeter enclosing
8 the extreme limits of the display surface or face of the sign including all frames, backing,
9 face plates, nonstructural trim or other component parts not otherwise used for support.

10 b. **Signs Without Backing.** The area of all signs without backing or a
11 background, material or otherwise, that is part of the overall sign display shall be
12 measured by determining the sum of the area of each square, rectangle, triangle, portion
13 of a circle or any combination thereof which creates the smallest single continuous
14 perimeter enclosing the extreme limits of each work, written representation (including
15 any series of letters), emblems or figures of similar character including all frames, face
16 plates, nonstructural trim or other component parts not otherwise used for support.

17 c. **All Other Signs or Combinations Thereof.** The area of any sign having parts
18 both with and without backing shall be measured by determining the total area of all
19 squares, rectangles, triangles, portions of a circle of any combination thereof constituting
20 the smallest single continuous perimeter enclosing the extreme limits of any of the

1 following combinations: the display surface or face of the sign including all frames,
2 backing, face plates, nonstructural trim or other component parts not otherwise used for
3 support for parts of the sign that have backing and each words, written representation
4 (including any series of letters), emblems or figures or a similar character including all
5 frames, face plates, nonstructural trim or other component parts not otherwise used for
6 support for parts of the sign having no backing.

7 **3. Building Front.** "Building front" means that exterior wall of a building facing the
8 front line of a premises.

9 **4. Display Surface or Face.** "Display surface or face" means the area made available by
10 the sign structure for the purpose of displaying the message.

11 **5. Distance of Sign Projection.** "Distance of sign projection" means the distance from
12 the exterior wall surface of the building to the display face of a wall sign.

13 **6. Electronic Message Center.** "Electronic message center" means a sign or device
14 capable of displaying letters, numbers, words, symbols, figures or images, including graphics,
15 that can be electronically, digitally or mechanically changed by remote or automatic means. This
16 definition includes what is commonly referred to as a "digital" sign or device.

17 **7. Exterior Wall Surface.** "Exterior wall structure" means the most exterior part of a
18 wall, sun screen or any screening or material covering a building.

1 8. **Flashing Signs.** "Flashing sign" means any directly or indirectly illuminated sign
2 either stationary or animated, which exhibits changing natural or artificial light or color effects
3 by any means whatsoever, including blinking, fluctuating scrolling or fading.

4 9. **Ground Sign.** "Ground sign" means a sign supported by poles, uprights or braces
5 extending from the ground or an object on the ground but not attached to any part of any
6 building. Height measurement for ground signs shall be from the grade level or the level of the
7 abutting roadway, whichever is higher.

8 10. **Illuminated Sign.** "Illuminated sign" means a sign lighted by or exposed to artificial
9 lighting either by lights on the sign or within the sign or directed towards the sign.

10 a. **Concealed Light Source.** Internal and external lighting, such as neon tubing,
11 flood lights, thin line and gooseneck reflectors are permitted provided the light source is
12 directed upon the face of the sign and is effectively shielded so as to prevent beams or
13 rays of light from being directed toward any person facing such sign or device upon any
14 public way or street and shall not be of such intensity so as to cause glare or impair the
15 vision of any person upon any public way or street or adjoining premises. Neon tubing
16 shall be enclosed in channels or covered by plastic faces.

17 b. **Exposed Light Source.** Internal and external lighting, such as neon tubing and
18 lamps are permitted, provided the intensity of such lighting shall not cause glare or
19 impair the visions of any person, facing such sign or device, upon any public way, street
20 or adjoining premises.

1 **11. Joint Identification Sign.** "Joint identification sign" means a sign which serves as
2 common or collective identification for two (2) or more businesses or industrial uses on the same
3 premises.

4 **12. Marquee Sign.** "Marquee sign" means a sign on or attached to a permanent
5 overhanging shelter that projects from the face of a building and is supported entirely by the
6 building and which sign is painted on or erected against the marquee. Said such signs shall not
7 exceed seven (7) feet in height nor shall they project below the face of the marquee nor lower
8 than ten (10) feet above the sidewalk. A marquee sign may extend the full length but in no case
9 shall it project beyond the ends of the marquee.

10 **13. On-premises Signs.** "On-premises sign" means a sign relating to products, goods,
11 services or uses which are conducted, sold, manufactured, produced, offered or occurs on the
12 same premises as the sign.

13 **14. Outdoor General Advertising Device.** "Outdoor general advertising device" means
14 a device maintained by advertising agencies which advertise products of their customers or
15 clients, and all business signs individually or privately owned which are not on the premises of
16 the owner or place of business to which they apply, including wall signs and those otherwise
17 attached to buildings and structures or devices, as well as those not attached to buildings and
18 supported by uprights or braces on the ground.

19 **15. Projecting Sign.** "Projecting sign" means a sign attached to a building at an angle,
20 provided:

1 a. There is no more than one such sign for each entrance door to a business
2 establishment;

3 b. It projects no more than five (5) feet from the building;

4 c. The sign advertises a use which occupies at least eighteen (18) feet of sign
5 frontage;

6 d. The bottom of the sign is at least ten (10) feet from grade and its top is no
7 higher than whichever of the following is highest: forty (40) feet above grade, or the
8 height of the building at the building line; and

9 e. No support for a sign shall extend above the cornice line of a building to which
10 it is attached.

11 16. **Roof Line.** "Roof line" means the highest point on any building where an exterior
12 wall encloses usable floor area including floor area provided for housing mechanical equipment.

13 17. **Roof Sign.** "Roof sign" means an on-premises sign which projects above the roof line
14 or is located on the roof of a building or structure.

15 18. **Sign.** "Sign" means any object or device or part thereof situated outdoors which is
16 used to advertise, identify, display, direct or attract attention to an object, person, institution,
17 organization, business product, service, event, or location by any means including words, letters,
18 figures, designs, symbols, fixtures, colors, motion, illumination or projected images. Signs do not
19 include the following:

20 a. Flags of nations, states and cities, fraternal, religious and civic organization;

- 1 b. Merchandise, pictures of models of products or services incorporated in a
- 2 window display;
- 3 c. Time and temperature devices;
- 4 d. Any civic symbols or crests which do not identify a business;
- 5 e. Works of art which in no way identify a product.

6 If for any reason it cannot be readily determined whether or not an object is a sign, the
7 Planning Commission shall make such determination.

8 **19. Sign with Backing.** "Sign with backing" means any sign that is displayed upon,
9 against or through any material or color surface or backing that forms an integral part of such
10 display and differentiates the total display from the background against which it is placed.

11 **20. Sign without Backing.** "Sign without backing" means any word, letter, emblem,
12 insignia, figure or similar character or group thereof, that is neither backed by, incorporated in or
13 otherwise made part of any larger display area.

14 **21. Sign Frontage.** "Sign frontage" means the length along a ground floor building front,
15 facing a street or a private way accessible from a street, which is occupied by a separate and
16 distinct use or by the same use which occupies the front of said building.

17 **22. Street Front.** "Street front" means any boundary line of a premises or parcel of land
18 that runs parallel to and within twenty (20) feet of the right-of-way of a street or highway
19 designated and assigned an individual name or number by the legislative action of the
20 municipality.

1 23. **Street Property Line.** "Street property line" means a common boundary between
2 private property and a dedicated street or alley.

3 24. **Temporary Sign.** "Temporary sign" means any exterior sign or advertising display
4 constructed of cloth, canvas, fabric, plywood, metal or other material intended to be displayed
5 for a short period of time not in excess of six (6) months.

6 25. **Vehicle Sign.** "Vehicle sign" means a sign mounted upon, painted upon or otherwise
7 erected on or affixed to trucks, cars, boats, trailers and other motorized vehicles or equipment.
8 This does not include business signs that are permanently painted on, or magnetically attached to
9 motor vehicles or rolling stock that are regularly and consistently used to conduct normal
10 business activities.

11 26. **Wall Sign.** "Wall sign" means a sign attached to, painted on, or erected against a wall
12 or parapet wall of a building or structure which extends no more than twenty-four (24) inches
13 from the wall surface upon which it is attached and whose display surface is parallel to the face
14 of the building to which the sign is attached.

15 27. **Wind Sign.** "Wind sign" means any sign in the nature of a series of two (2) or more
16 banners, flags, pennants or other objects or material which call attention to a product or service
17 fastened in such a manner as to move upon being subjected to pressure by wind or breeze.

18 28. **Window Sign.** "Window sign" means a sign which is applied or attached to, or
19 located within three (3) feet of the interior of a window, which sign can be seen through the
20 window from the exterior of the structure.

2 The following described signs are not covered by the rules and regulations set forth below in
3 Section 26.68.060 and a building permit for any of the following described signs, if necessary,
4 may be issued by the Building Commissioner without the said Commissioner determining if said
5 sign complies with such rules or regulations.

6 A. Signs required or specifically authorized for a public purpose by any law, statute, or
7 ordinance; may be of any type, number, area, height, above grade, location, illumination or
8 animation, authorized by law, statute or ordinance under which the signs are required or
9 authorized.

10 B. Signs of danger or a cautionary nature which are limited to: wall and ground signs; not
11 more than two (2) per street front for each conforming use, or two (2) for each dwelling unit; not
12 more than four (4) square feet per sign in area; not more than ten (10) feet in height above grade;
13 may be illuminated only from a concealed light source which does not flash, blink, fade, scroll,
14 or fluctuate; and shall not be animated.

15 C. Signs in the nature of cornerstones, commemorative tables and historical signs which
16 are limited to: wall and ground signs; not more than two (2) per premises; not more than six (6)
17 feet in height above grade; may be illuminated only from a concealed light source which does
18 not flash, blink, fade, scroll, or fluctuate; shall not be animated.

19 D. Signs which identify by name or number individual buildings within institutional or
20 residential building group complexes and which are limited to: wall and ground signs; not more

1 than four (4) signs per building; not more than ten (10) square feet per sign in area; not more
2 than twelve (12) feet in height above grade; any location on the premises; may be illuminated
3 only from a concealed light source which does not flash, blink, fade, scroll or fluctuate and shall
4 not be animated.

5 E. Signs in the nature of decorations, clearly incidental and customary and commonly
6 associated with any national, local or religious holiday; provided that such signs shall be
7 displayed for a period of not more than sixty (60) consecutive days nor more than sixty (60) days
8 in any one year; and may be of any type, number, area, height, location, illumination or
9 animation.

10 F. Signs in the display window of a business use which are incorporated into a display of
11 merchandise or a display relating to services offered on the same premises and limited to:
12 window signs; one (1) sign per five (5) feet of window frontage; not more than eight (8) square
13 feet per sign in area; ground level windows only; may be illuminated only from a concealed light
14 source which does not flash, blink, fade, scroll or fluctuate; shall not be animated.

15 G. Signs commonly associated with and limited to information and directions relating to
16 the conforming use on the premises on which the sign is located, provided that each such sign is

5 **3. Nonconforming Uses in Zone District F Local Business.** Signs may be

9 **4. Nonconforming Uses in Zone Districts G and H.** Signs may be erected,

12 and H as set out herein above in Section 26.68.100.

13 **5. Nonconforming Uses in Zone Districts I, J, K and L.** Signs may be erected,

17 **26.68.150 Nonconforming signs.**

1 **B. Definition of Nonconforming Signs.** A nonconforming sign shall be any sign which:

2 1. On the effective date of this ordinance was lawfully maintained and had been
3 lawfully erected in accordance with the provisions of any prior zoning ordinance but
4 which sign does not conform to the limitations established by this ordinance in the district
5 in which the sign is located; or

6 2. On or after the effective date of this ordinance was lawfully maintained and
7 erected in accordance with the provisions of this ordinance but which sign, by reason of
8 amendment to this ordinance after the effective date thereof does not conform to the
9 limitations established by the amendment to this ordinance in which the sign is located.

10 3. **Continuance of Nonconforming Signs.** Subject to the termination hereinafter

13 changed in any manner that increases the noncompliance of such sign with the provisions
14 of this ordinance established for signs in the district in which the sign is located; and,
